PEAK PERFORMANCE COACHING AGREEMENT TERMS AND CONDITIONS

1. I agree to coaching with either Dr. Johnson or one of his coaching associates. The amount will be charged by credit card or electronic check debit on a monthly basis only. There is no per appointment rate.
2. I understand that the coach will call me at a pre-appointed time and that if I miss an appointment, it is up to me to reschedule for that week. Appointments can't be made up in later weeks unless by previous agreement with the coach. Coaching is billed on a monthly basis, not per appt.
3. I represent and warrant that I am entering into this agreement for business purposes only, and am prohibited from using any of the information for any other purposes without the expressed written consent of Dr. Kerry Johnson /IPS.
4. Monthly coaching calls are defined as 4 telephone coaching sessions per month for 30 minutes or longer.
5. The laws of the state of California govern the agreement, In the event of any action hereunder, venue shall be proper in the county of Orange, State of California, and I consent to service of process by mail.
6. This agreement will be in force for a period of 6 months from the date of the first appointment. I can cancel anytime in the first month with an associate or after the 6th month with an associate or Dr. Johnson. There is no first month cancellation with Dr. Johnson. The first month with an associate coach is non-refundable. The 6 months with Dr. Johnson is non-refundable. After 6 months, coaching will continue on a month to month basis and will discontinue only by written correspondence dated upon receipt at PO Box 3665, Tustin, CA 92781
